Clean Water State Revolving Fund (CWSRF) FY 2010 Intended Use Plan (IUP) Proposed Amendment II May 4, 2010

Revision of FY 2010 Intended Use Plan and Project Priority List (PPL)

In accordance with program regulations, the CWSRF FY 2010 IUP, a strategic plan outlining the program's financial and pollution control goals and activities for FY 2010, is being amended to include the new provision of the FY 2010 Capitalization Grant within the FY 2010 IUP which became effective July 1, 2009. In doing so, the Oklahoma Water Resources Board (OWRB) will be able to utilize a portion of these funds within SFY 2010. In addition, three wastewater construction projects will be added to the FY 2010 PPL. These projects were proposed following Amendment I, issued on September 28, 2009 and the subsequent approval of the FY 2010 IUP.

The FY 2010 CWSRF PPL has been revised to reflect these changes (attached). Eligibility requirements for CWSRF projects are identified in Section 212 of the Federal Clean Water Act and OWRB CWSRF program administration rules. Other CWSRF loan projects anticipating funding during FY 2010 will not be adversely affected by these amendments.

I. New 2010 Requirements:

a. Additional Subsidies – The FY 2010 Appropriations Bill states that "Provided further, That not less than 30 percent of the funds made available under this title to each State for Clean Water State Revolving Fund capitalization grants...shall be used by the State to provide additional subsidy to eligible recipients in the form of forgiveness of principal, negative interest loans, or grants (or any combination of these), except that for the Clean Water State Revolving Fund capitalization grant appropriations this section shall only apply to the portion that exceeds \$1,000,000,000."

Additional subsidies from the FY 2010 Appropriations Bill may be provided to projects or phases of projects not funded from the American Recovery and Reinvestment Act of 2009 (ARRA). The OWRB will target the additional subsidies, first to projects eligible under the Green Project Reserve and second to disadvantaged communities as defined through the 30 year financing negotiation under the Drinking Water State Revolving Fund. As funding is available, it is proposed that 15% of a project's costs up to \$500,000 or the cost of the green component of the project whichever is less will be available in the form of principal forgiveness as permitted

under the FY 2010 Appropriations Act. The remaining funds will be available in the form of a below market interest rate CWSRF loan.

- b. Green Project Reserve (GPR) The FY 2010 Appropriations Bill states that "Provided, that for fiscal year 2010, to the extent there are sufficient eligible project applications, not less than 20 percent of the funds made available under this title to each State for Clean Water State Revolving Fund capitalization grants....shall be used by the State for projects to address green infrastructure, water or energy efficiency improvements or other environmentally innovative activities." This requirement continues the framework set forth under ARRA. OWRB intends to utilize existing procedures as outlined on page 9 of Oklahoma's FY 2010 IUP supplemented with FY 2010 guidance issued on April 21, 2010 by the Environmental Protection Agency regarding the Determination of GPR Eligibility. At this time, OWRB has not identified sufficient projects to meet the FY 2010 Appropriations Bill's 20 percent GPR requirement. An Amended GPR project list will be submitted prior to funding of additional GPR projects.
- c. Davis Bacon The FY 2010 Appropriations Bill states that : "For fiscal year 2010 the requirements of section 513 of the Federal Water Pollution Control Act (22 U.S. C. 1372) shall apply to the construction of treatment works carried out in whole or in part with assistance made available by a State water pollution control revolving fund as authorized by title VI of that Act (22 U.S. C. 1381 et seq.), or with assistance made available under section 205(m) of that Act (33 U.S.C. 1285(m)), or both."
- d. Reporting Requirements The FY 2010 Appropriations Bill placed new reporting requirements on the SRF program. Oklahoma will not only track how additional subsidies are used, but also "by what types of communities." Oklahoma will report quarterly as required via the CWSRF Benefits Reporting System.

II. Priority List Revisions:

<u>Addition of New Projects</u>- The entities of Muskogee Utilities Authority, Bartlesville Municipal Authority, and Oklahoma City Water Utilities Trust have submitted requests to be considered for loan funding. The request for funding has been added to the FY 2010 PPL (July 2009- June 2010).

<u>Other changes</u>- Several entities with projects listed on the FY 2010 CWSRF PPL have requested changes due to revised project items or construction estimates and/or target project approval dates. The list has been revised to reflect these adjustments. Total funds required for projects yet to be funded on the FY 2010 equals \$150,664,342.00.

III. Public Notice:

This amendment is being made with adequate public notice in accordance with the procedures provided in 40 CFR Part 35 Subpart K Paragraph 35.3150(c) and Chapter 50, Part 3 of the OWRB CWSRF Regulations. The OWRB will issue a notice, on May 4, 2010 with a summary of the amendment, entitled Amendment No. 2 to the FY 2010 IUP, on the OWRB website, and distribute announcements to public wastewater authorities currently listed on the IUP, state and federal agencies, and other stakeholders.
