Revision of FY 2011 Project Priority List (PPL)

The CWSRF FY 2011 IUP, a strategic plan outlining the program's financial and pollution control goals and activities for FY 2011, includes as Appendix A to the PPL which details communities that have expressed interest in participating in the program. In accordance with program regulations, the FY 2011 PPL is being amended to reflect an updated Green Project Reserve (GPR) Priority List and associated proposed additional subsidization amounts as required under the FY 2010 Appropriations Provisions. In addition, one wastewater construction projects are being added to the FY 2011 PPL. These revisions and projects were proposed following the issuance of Amendment II to the PPL on December 20, 2010.

The FY 2011 CWSRF PPL has been revised to reflect these changes (attached). Eligibility requirements for CWSRF projects are identified in Section 212 of the Federal Clean Water Act and OWRB CWSRF program administration rules. Other CWSRF loan projects anticipating funding during FY 2011 will not be adversely affected by these amendments.

I. Additional Requirements:

GPR Priority List with Additional Subsidization — The OWRB has identified seven projects eligible for GPR subsidization. At this time, a sufficient amount of projects have not been identified to meet the FY 2010 Appropriations Provisions of 30 percent additional subsidy requirements. Future amendments to the PPL with a GPR project list with additional subsidization will be submitted prior to funding of GPR projects. II. Priority List Revisions:

Addition of New Project- The Tulsa Metropolitan Utility Authority submitted a request to be considered for loan funding. These requests have been added to the FY 2012 PPL (July 2011- June 2012).





Other changes- Several entities with projects listed on the FY 2011 CWSRF PPL have requested changes due to revised project items or construction estimates and/or target project approval dates. The list has been revised to reflect these adjustments. Total funds required for projects yet to be funded in FY 2011 equals \$65,443,479.

III. Public Notice:

This amendment is being made with adequate public notice in accordance with the procedures provided in 40 CFR Part 35 Subpart K Paragraph 35.3150(c) and Chapter 50, Part 3 of the OWRB CWSRF Regulations. The OWRB will issue a notice, on March 10, 2011 with a summary of the amendment, entitled Amendment No. 3 to the FY 2011 Project Priority List, on the OWRB website, and distribute announcements to public wastewater authorities currently listed on the PPL and other stakeholders.
