ORDER

On January 30, 2015, the above-captioned matter came for hearing on the Motion for *In Camera* Inspection of Documents filed jointly by petitioners Oklahoma Farm Bureau Legal Foundation, Oklahoma Aggregates Association, TXI, and Arbuckle-Simpson Aquifer Protection Federation of Oklahoma, Inc. (collectively "Petitioners"). Petitioners as well as respondents Oklahoma Water Resources Board ("OWRB") and Citizens for the Protection of the Arbuckle-Simpson Aquifer ("CPASA") each appeared respectively through counsel of record. Petitioners' motion asks this Court to conduct an *in camera* review of an unredacted version of a memorandum dated September 14, 2012, a redacted version of which was attached to their Motion to Compel Production of Unredacted OWRB Memorandum as Exhibit B.

After reviewing the parties' briefs and further hearing argument on behalf of the parties at the January 30, 2015 hearing, the Court ordered the OWRB to produce an unredacted copy of the memo for review *in camera*. Thereafter, the OWRB submitted an unredacted copy of the memo, which the Court then reviewed *in camera*. Based on the Court's *in camera* review, and having considered the parties' filings and the arguments heard, it is hereby ORDERED, ADJUDGED, AND DECREED as follows:

1. Petitioners' Motion for *In Camera* Inspection of Documents is GRANTED.
2. The September 14, 2012 Memorandum does not contain privileged information. The OWRB is required to produce to Petitioners an unredacted version of the entire September 14, 2012 Memorandum.

IT IS SO ORDERED, this 9th day of February, 2015.




