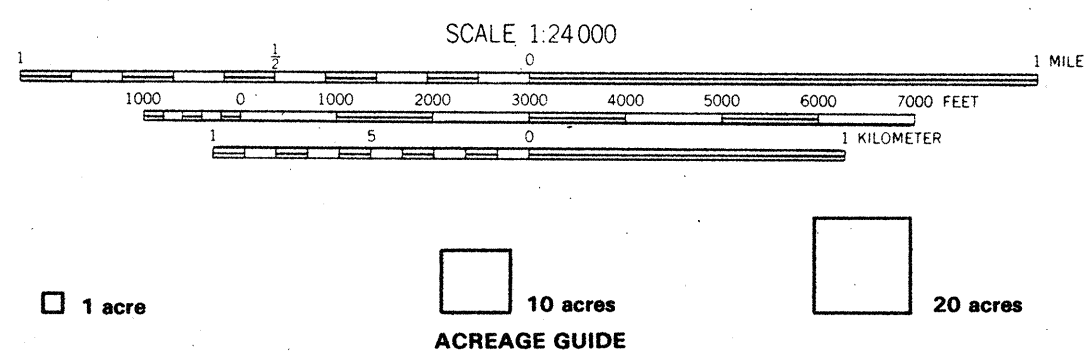

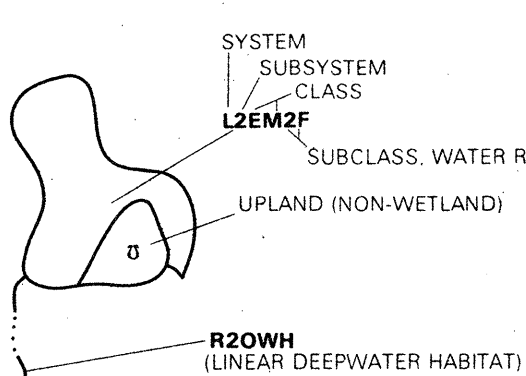

SPECIAL NOTE

This document was prepared primarily by stereoscopic analysis of high altitude aerial photographs. Wetlands were identified on the photographs based on vegetation, the visible hydrology, and the geographic location in relation to the United States Geological Survey's "Detailed Land Use and Land Cover Data" (FWS/OBS-79/31 December 1979). The aerial photographs typically reflect conditions during the specific year and season when they were taken. In addition, there are some limitations to the use of aerial photographs in wetland photography. Thus, a detailed on the ground and historical analysis of a single site may result in a revision of the wetland boundaries established through photographic interpretation. In addition, some small wetlands and those with dense forest cover may not be included on this document.

Federal, State and local regulatory agencies with jurisdiction over wetlands may define and describe wetlands in a different manner than that used in this inventory. There is no attempt, in either the design or products of this inventory, to define the limits of proprietary jurisdiction of any Federal, State or local government or to establish the geographical scope of the regulatory programs of government agencies. Persons intending to engage in activities involving modifications with or adjacent to wetlands should consult with the agency of appropriate jurisdiction. State or local agencies concerning specified agency regulatory programs and proprietary jurisdictions that may affect such activities.

- Some areas designated as R4SB, R4SBW, OR R4SBJ (INTERMITTENT STREAMS) may not meet the definition of wetland.
- This map uses the class Unconsolidated Shore (US).
- On the US NAVI maps that class was designated Beach/Bar (BB), or Flat (FL). Subclasses remain the same in both versions.
