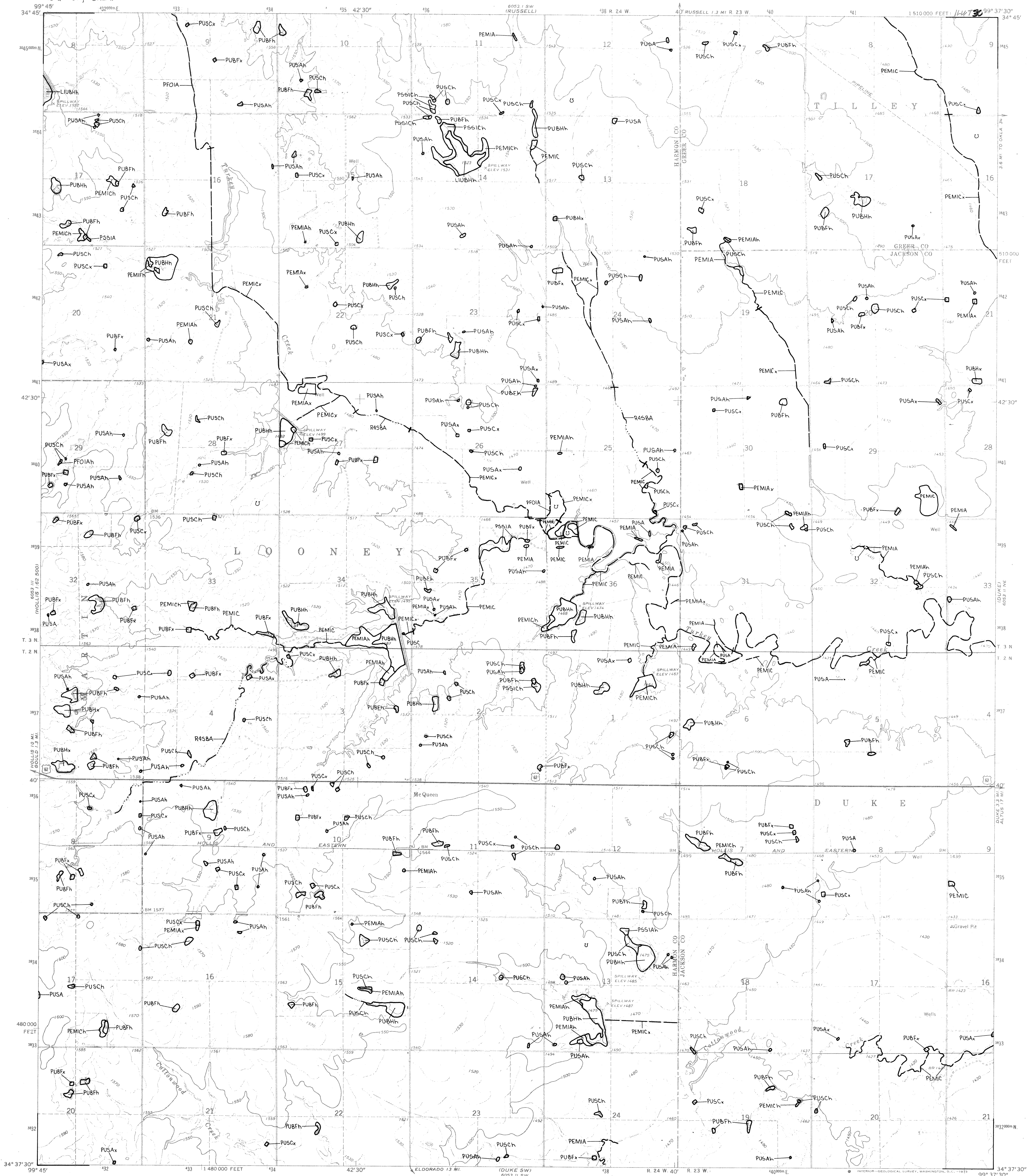


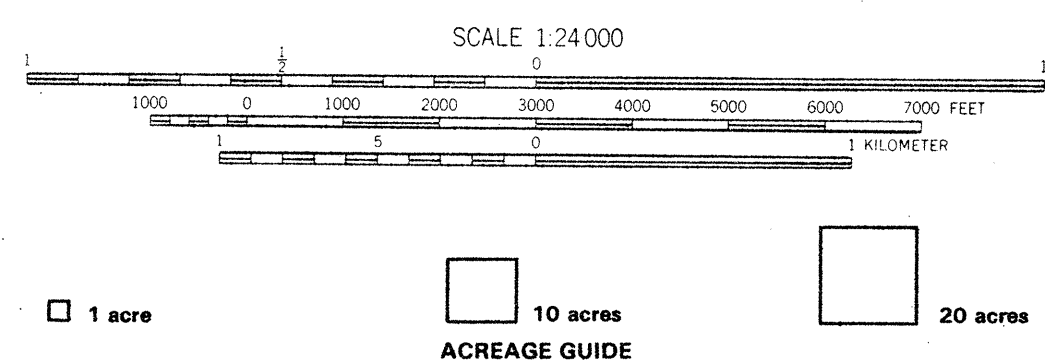

SPECIAL NOTE

SPECIAL NOTE This document was prepared primarily by stereoscopic analysis of high altitude aerial photographs. Wetlands were identified on the photographs based upon vegetation, visible hydrology, and geography in accordance with **Classification of Wetlands and Deepwater Habitats of the United States (FWS/OBS - 752 31 December 1979)**. The aerial photographs typically reflect conditions during the specific year and season when they were taken. In addition, there is a margin of error inherent in the use of the aerial photographs. Thus, a detailed on the ground and historical analysis of a single site may result in a revision of the wetland boundaries established through photographic interpretation. In addition, some small wetlands and those obscured by dense forest cover may not be included on this document.

SYMBOLGY EXAMPLE

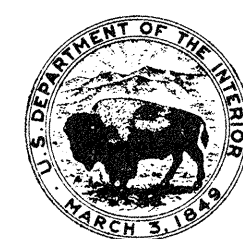

- Some areas designated as R4SB, R4SBU, OR R4SBJ (INTERMITTENT STREAMS) may not meet the definition of wetland.
- This map uses the class Unconsolidated Shore (US). On earlier NWI maps that class was designated Beach/Bar (BB), or Flat (FL). Subclasses remain the same in both versions.
