The Acreage Guide includes three scales:

- Distance Scales:**
 - Miles:** A scale from 0 to 1 mile, with markings every 1000 feet (0, 1000, 2000, 3000, 4000, 5000, 6000, 7000).
 - Kilometers:** A scale from 0 to 1 kilometer, with markings every 500 meters (0, 500, 1000).
- Area Scales:**
 - 1 acre:** Represented by a small square.
 - 10 acres:** Represented by a medium square.
 - 20 acres:** Represented by a large square.
