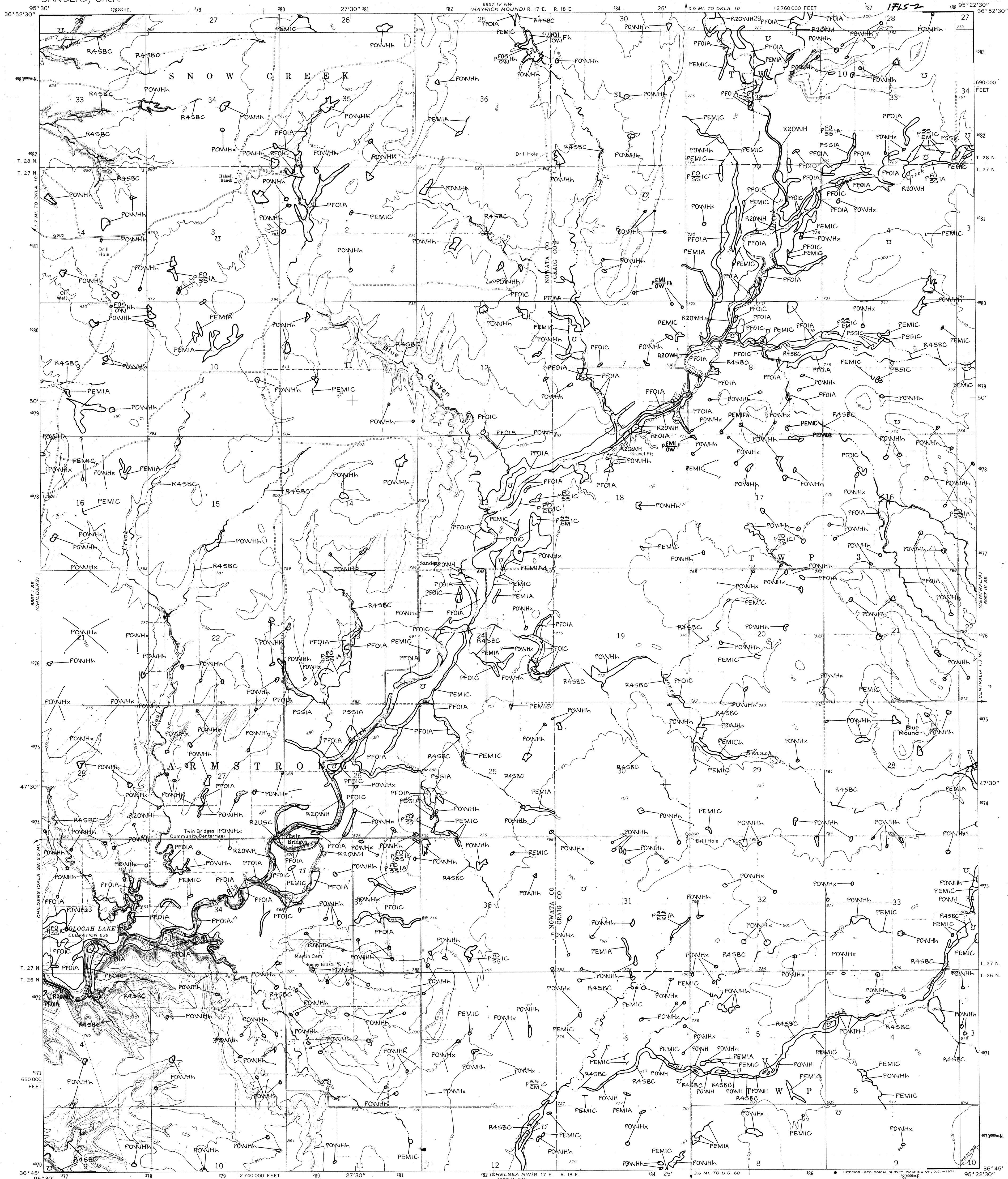

SPECIAL NOTE

This document was prepared primarily by stereoscopic analysts of high altitude aerial photographs. Wetlands were identified on the photographs based on vegetation, visible water, and other features. The document is a revision of the *Inventory of Wetlands and Deep-Water Habitats of the United States* (An Operational Draft), Cowardin, et al. 1977. The aerial photographs typically reflect conditions during the specific year and season of the photograph. There is a margin of error inherent in the use of the aerial photographs. Thus, a detail on the ground and historical analysis of a single site may result in a revision of the wetland boundaries established through photographic analysis. In addition, some small wetlands and those obscured by dense forest cover may not be included on this document.

Federal, State and local regulatory agencies with jurisdiction over wetlands may define and describe wetlands in a different manner than that used in this inventory. There is no attempt, in either the design or products of this inventory, to define the limits of proprietary jurisdiction of any Federal, State or local government or to establish the geographical scope of the regulatory programs of government agencies.
