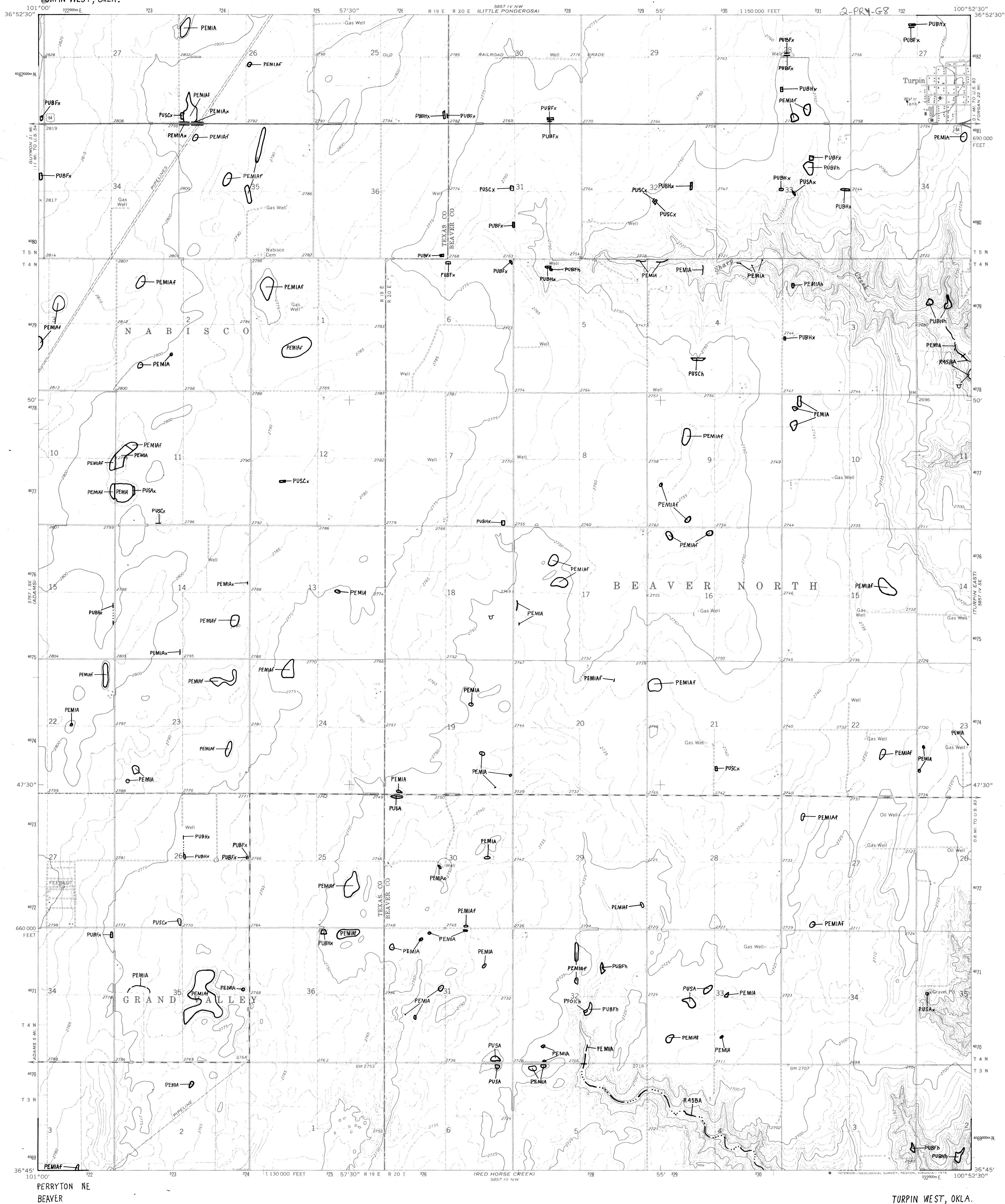
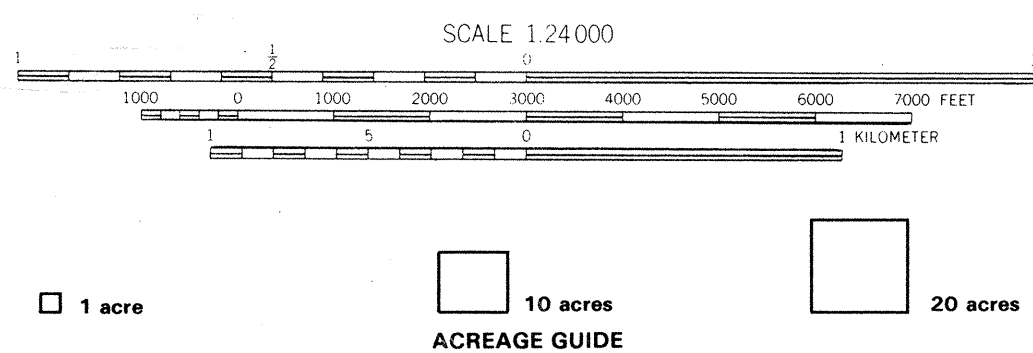

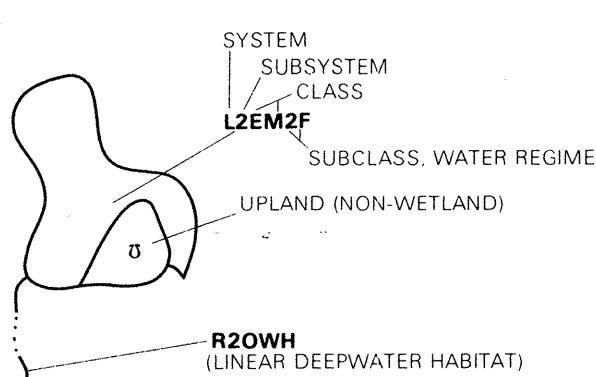
SPECIAL NOTE

SPECIAL NOTE

This document was prepared primarily by stereoscopic analysis of high altitude aerial photographs. Wetlands were identified from aerial photographs based on vegetation, visible hydrology, and geography in accordance with **Classification of Wetlands and Deepwater Habitats of the United States (FWS/OBS - 79/31 December 1979)**. The aerial photographs typically reflect conditions during the specific year and season when they were taken. In addition, there is a margin of error inherent in the use of the aerial photographs. Thus, a detailed on the ground and historical aerial photograph comparison is required to determine if wetland boundaries established through photographic interpretation. In addition, some small wetlands and those obscured by dense forest cover may not be included on this document.

Federal, State and local regulatory agencies with jurisdiction should be able to define and describe wetlands in a different manner than that used in this inventory. There is no attempt, in either the design or products of this inventory, to define the limits of proprietary jurisdiction of any Federal, State or local government or to establish the geographical scope of the regulatory programs of government agencies. **Persons intending to engage in activities involving modifications within or adjacent to wetland or areas shall seek approval from the appropriate Federal agency or agencies concerning specified agency regulatory programs and proprietary jurisdictions that may affect such activities.**

- Some areas designated as R4SB, R4SBW, OR R4SBJ (INTERMITTENT STREAMS) may not meet the definition of wetland.
- This map uses the class Unconsolidated Shore (US). On earlier NWI maps that class was designated Beach/Bar (BB), or Flat (FL). Subclasses remain the same in both versions.
