APPLICANT’S FIRST REQUEST FOR DISCOVERY

Pursuant to O.A.C. § 785:4-5-1 and the instructions of the Hearing Examiner at the pre-hearing conference, the City of Oklahoma City (“City”) respectfully requests that you respond to discovery below regarding Permit Application No. 2007-0017. You are receiving this request because you submitted a written protest regarding the City’s stream water permit application. The purpose of this request is to help determine which interested persons may have party status in the upcoming hearing on August 21, 2017. 
